4.1 Public and private enterprises, public institutions of direct and indirect administrations and of Legislative and Juridical Authorities, that have employees governed by the Consolidation of Labor Laws (CLT), shall maintain Specialized Services in Occupational Safety and Health, in order to promote health and protect the integrity of the workers at the workplace. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2 The size of the Specialized Services in Occupational Safety and Health is linked to the risk level of the main activity and the total number of employees of the establishment, as shown in Table I and II, annexes, subject to the exceptions within this NR. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.1 For the purposes of dimensioning, the construction sites and the work fronts with less than 1 (one) thousand employees and located in the same state, territory or Federal District shall not be considered as establishments, but as members of the main engineering enterprise responsible, which shall organize Specialized Services in Occupational Safety and Health. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.1.1 In this case, occupational safety engineers, occupational physicians and occupational nurses might be centralized. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.1.2 The number of occupational safety technicians and auxiliary occupational nurses shall be determined according to construction site or work front, as shown in Table II. *(Amended by SSMT Ordinance no. 34, of December 11st, 1987)*

4.2.2 Enterprises with more than 50% (fifty percent) of their employees in establishments or active sectors whose risk level is higher than the main activity shall size the Specialized Services in Occupational Safety and Health according to higher risk level, complying with the provision in Table II of this NR. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.3 The enterprise may constitute centralized Specialized Service in Occupational Safety and Health to assist a number of establishments that belong to it, provided that the distance between the location of the service and each of the other locations do not exceed 5,000 (five thousand) meters, and the service size shall comply with the total number of employees and risk level according to Table II and sub-item 4.2.2. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.4 If the enterprise has establishment(s) that falls within Table II, and other(s) that do not, the service for this establishment(s) shall be provided by specialized services of that establishment(s), which shall be sized according to sub-item 4.2.5.1 and 4.2.5.2, as long as they are located in same state, territory or Federal District. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.5 If the enterprise has only establishments which, alone, do not fall within Table II, compliance with this NR shall be provided by Specialized Services in Occupational Safety and Health centralized in each state, territory or Federal District, provided that the total number of employees at the establishments in the state, territory or Federal District reaches the limits specified in Table II, applied the provisions of sub-item 4.2.2. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

nance no. 33, October 27th, 1983)

4.2.5.1 For enterprises classified in risk level 1, the size of the services referred to in sub-item 4.2.5 shall comply with Table II, considering as the number of employees the sum of employees located in the establishment with the largest number and the arithmetic average of the number of employees in other establishments. All professionals of the Specialized Services in Occupational Safety and Health, thus constituted, shall be full time members. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.2.5.2 For enterprises classified in risk level 2, 3 and 4, the size of services referred to in sub-item 4.2.5 shall comply with Table II, considering the sum of employees in all establishments as the number of employees. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.3 The enterprises classified in risk level 1 that are obliged to constitute Specialized Services in Occupational Safety and Health, which have other engineering and medical services, may integrate these services with the Specialized Services in Occupational Safety and Health, constituting a unique engineering and medical service. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.3.1 The enterprises that opt for unique engineering and medical services are obliged to prepare and submit for approval by the Secretariat of Occupational Safety and Health, until March 30th, a biennial program of occupational safety and medicine that will be developed. *(Amended by SSMT Ordinance no. 33, of October 27th, 1983)*

4.3.1.1 The new enterprises that establish after March 30th of each year may constitute the unique service mentioned in sub-item 4.3.1 and prepare their program to be submitted to the Secretariat of Occupational Safety and Health, within 90 (ninety) days after their establishment. *Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.3.1.2 The new enterprises that are members of business groups that already have unique service may be assisted by that service after notice to the DRT. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.3.2 The Secretariat of Occupational Safety and Health reserves the right to monitor the execution of the program and to assess its effectiveness. *Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.3.3 The unique medical and engineering service shall have specialized professionals according to Table II of this NR. *(Amended by MTPS Ordinance*

no.510, of April 29th, 2016)

4.3.4 The sizing of the unique engineering and medical service shall comply with the provisions of Table II of this NR for specialized professionals. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.4 Specialized Services in Occupational Safety and Health shall be composed of Occupational Physician, Occupational Safety Engineer, Occupational Safety Technician, Occupational Nurse and Occupational Nursing Auxiliary or Technician in accordance with Table II of this NR. *(Amended by MTE Ordinance no. 590, of April 28th, 2014)*

4.4.1 The professional members of SESMT shall have training and professional registration in accordance with occupational regulations and normative instruments issued by relevant Professional Counsel, if there are any. (NR) *(Amended by MTE Ordinance no. 590, of April 28th, 2014 – Check deadline on MTE Ordinance no. 2.018, of December 23rd, 2014).*

4.4.1.1 With respect to the Occupational Safety Engineer and the Occupational Safety Technician, the provisions in Law no. 7.410 of November 27th, 1985 shall be observed. *(Amended by MTE Ordinance no. 2.018, of December 23rd, 2014)*

4.4.2 The professional members of the Specialized Services in Occupational Safety and Health shall be employees of the enterprise, except in the cases provided in item 4.14 and 4.15. *(Amended by DSST Ordinance no. 11, of September 17th, 1990)*

4.5 The enterprise that hires other(s) to provide services in establishments classified in Table II, shall provide its Specialized Services in Occupational Safety and Health to the employee(s) of the contracted enterprise, when the number of employees of the contracted enterprise that carry out activities in those establishments does not reach the limits specified in Table II, and the contracted enterprise shall also comply with sub-item 4.2.5. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.5.1 When the contracting enterprise and the others it contracts do not fall within the Table II, but the total number of employees of both enterprises in the establishment reaches the limits referred in Table II, a joint Specialized Service in Occupational Safety and Health shall be established in the manner of item 4.14. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.5.2 When the contracted enterprise does not fall within Table II, even considering the total number of employees in the establishments, the contract-

ing party shall provide its Specialized Services in Occupational Safety and Health to the employees of the contracted enterprise, whether they are centralized or in establishments. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.5.3 The enterprise that contracts others to perform services in its establishment may constitute a joint SESMT for assistance to the employees of the contracted enterprise, under its management, if so provided for in the Collective Labor Agreements and Conventions. *(Amended by SIT Ordinance no. 17th, of August 01, 2007)*

4.5.3.1 The size of the SESMT organized in the manner specified in sub-item 4.5.3 shall consider the sum of the assisted workers and economic activity in the establishment of the contracting enterprise. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.5.3.2 In the case provided in item 4.5.3, the number of employees of the contracted enterprise and assisted by the joint SESMT in the establishment of contracting enterprise, is not included in the calculation for sizing the SESMT of the contracted enterprise. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.5.3.3 The SESMT organized according to sub-item 4.5.3, shall have its operation evaluated on a semi-annual basis by a Committee composed of representatives of the contracting enterprise, the worker unions and the Regional Labor Office, or in the form and frequency provided for in the Collective Labor Agreements and Conventions. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.6 The size of the Specialized Services in Occupational Safety and Health of the enterprises operating on seasonal basis shall be calculated in accordance with Table I and Table II, taking the arithmetic average of the number of employees in the previous calendar year into account. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.7 The Specialized Services in Occupational Safety and Health shall be led by a qualified professional in accordance with the requirements specified in sub-item 4.4.1 of this Regulatory Norm. *(Amended by DSST Ordinance no. 11, of September 17th, 1990)*

4.8 The occupational safety technician and occupational nursing assistant shall devote 8 (eight) hours per day for the activities pertaining to the Specialized Services in Occupational Safety and Health in accordance with the provisions of Table II, annex. *(Amended by SSMT Ordinance no. 34, of De-*

ember 11th, 1987)

4.9 The occupational safety engineer, the occupational physician and the occupational nurse shall devote a minimum 3 (three) hours (part-time) or 6 (six) hours (full-time) per day for the activities pertaining to the Specialized Services in Occupational Safety and Health in accordance with the provisions of Table II, respecting the relevant legislation in effect. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.9.1 With respect to the occupational physician, in order to comply with the activities of the Specialized Services in Occupational Safety and Health in a full-time term, the enterprise may hire more than one professional provided that each devote at least 3 (three) hours of work, requiring the sum of the daily hours worked by all to be a minimum 6 (six) hours. *(Inserted by MTE Ordinance no. 590, of April 28th, 2014)*

4.10 The professional specialized in Occupational Safety and Health is prohibited from engaging in other activities in the enterprise during the time of their work in Specialized Services in Occupational Safety and Health. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.11 All expenses arising from the installation and maintenance of the Specialized Services in Occupational Safety and Health shall be exclusively on the account of the employer. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.12 It is the responsibility of the professional members of Specialized Services in Occupational Safety and Health to: *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

- a) apply their knowledge on occupational health and safety engineering to the workplace and all its components, including machines and equipment's, in order to reduce or even eliminate the existing risks to the health of the workers;
- b) determine the use of Personal Protective Equipment (PPE) by the worker in accordance with the NR6, when all known measurements to eliminate the risk are inadequate, and the risk persists, even reduced, provided that the concentration, intensity or characteristics of the agent requires it;
- c) collaborate in design and implementation of new physical and technological facilities of the enterprise, exercising the willing competency in the subsection "a", when required;
- d) be technically responsible for guidance regarding to compliance with the provisions in the NR applied to the activities undertaken by the en-

terprise and/or its establishments;

- e) keep permanent relationship with the CIPA, taking maximum advantage of its comments, in addition to support, train and assist it, as established in NR5;
- f) promote the realization of awareness raising activities, training and guidance for the workers in order to prevent occupational accidents and occupational diseases, both through campaigns and as a permanent term programs;
- g) clarify and raise awareness of the employers' on occupational accidents and occupational diseases, encouraging them in favor of prevention;
- h) analyze and log in specific document(s) all the accidents occurred in the enterprise or establishment, with or without any victim, and all the occupational diseases cases, describing the history and characteristics of the accident and/or occupational disease, the environmental factors, the characteristics of the agent and the condition of the individual(s) accidented or with occupational disease;
- i) register, on a monthly basis, the updated data of occupational accidents, occupational diseases and hazardous agents by filling, at the minimum, the requisites described in the templates contained in Table III, IV, V and VI, and the employer shall maintain the documentation available to the labor inspectorate; *(Amended by MTE Ordinance no. 2.018, December 23rd, 2014)*
- j) keep the records mentioned in subsections "h" and "i" in the office of Specialized Services in Occupational Safety and Health or an easily reachable place according to enterprise's archiving and retrieval method, provided that access to the records and understanding of their contents is ensured. Annual evaluation forms corresponding to the subsections "h" and "i" shall be kept for a period not less than 5 (five) years;
- l) the activities of the professional members of Specialized Services in Occupational Safety and Health are essentially preventive, although emergency care is not prohibited when it becomes necessary. However, the development of plans to control the effects of disasters, the availability of measurements aimed at firefighting, and rescue and immediate attention to the victims of any accident are included in their activities.

4.13 The Specialized Services in Occupational Safety and Health shall keep permanent engagement with the CIPA, take advantage of it, and examine its comments and requests proposing corrective and preventive solutions conforming to the provisions in sub-item 5.14.1. of NR 5. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.14 The enterprises, whose establishments do not fall within Table II may

provide assistance in occupational health and safety to their employees through joint Specialized Services in Occupational Safety and Health organized by the union or association of the corresponding economic category or by the interested enterprises themselves. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.14.1 Maintenance of these Specialized Services in Occupational Safety and Health shall be made by the enterprises using it, that will participate in the expenditure in proportion to the number of employees of each enterprise. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.14.2 The Specialized Services in Occupational Safety and Health referred to in item 4.14 shall be sized properly with regard to the sum of the employees of the participating enterprises according to Table I and Table II, and item 4.2 in this NR. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.14.3 Enterprises with the same economic activity, located in the same municipality or in neighboring municipalities, whose establishments fall within Table II, may constitute a joint SESMT organized by the corresponding employers' union or by the interested enterprises themselves, if so provided in the Collective Labor Agreement or Convention. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.3.1 The joint SESMT may be extended to enterprises whose establishments do not fall within Table II, provided that other requirements of sub-item 4.14.3 are met. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.3.2 The size of SESMT which is organized in the manner that is described in sub-item 4.14.3 shall consider the sum of the assisted workers. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.3.3 In the case established in item 4.14.3, the number of employees assisted by the joint SESMT is not included in the calculation for sizing the enterprises' SESMT. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.3.4 The SESMT, organized in the manner established in sub-item 4.14.3, shall have its operation evaluated on a semi-annual basis by a Committee comprised of representatives from the enterprises, the labor unions and the Regional Labor Office, or in the form and frequency provided for in the Collective Labor Agreement or Convention. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.4. The enterprises that develop their activities in the same industrial or commercial hub may constitute a joint SESMT organized by the interested enterprises, if so provided for in the Collective Labor Agreement or Convention. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.4.1 The size of the joint SESMT organized in the manner specified in sub-item 4.14.4 shall consider the sum of the assisted workers and the economic activity that employs the largest number among the assisted workers. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.4.2 In the case established in item 4.14.4, the number of employees assisted by the joint SESMT is not included in the calculation for sizing the SESMT of the enterprises. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.14.4.3 The SESMT organized in the manner that is established in sub-item 4.14.4 shall have its operation evaluated on semi-annual basis by a Committee made up of representatives from the enterprises, the labor unions and the Regional Labor Office, or in the form and frequency provided for in the Collective Labor Agreement or Convention. *(Approved by SIT Ordinance no. 17, of August 1st, 2007)*

4.15 The enterprises referred to in item 4.14 may opt for the Specialized Services in Occupational Safety and Health from an official institution or private institution of public utility. In this case, the enterprises are responsible for the expenses, in the manner provided or in sub-item 4.14.1. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.16 The enterprises whose Specialized Services in Occupational Safety and Health do not have an occupational physician and/or occupational safety engineer in accordance with Table II of this NR may be able to use the services of these professionals in the Specialized Services in Occupational Safety and Health mentioned in item 4.14 and sub-item 4.14.1 or in item 4.15 in compliance with the provisions of the Regulatory Norms. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.16.1 The expenses arising from that use shall be incumbent upon the requesting enterprise. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.17 The Specialized Services in Occupational Safety and Health that are treated in this NR shall be registered in the regional agency of the Ministry of Labor. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.17.1 The registration referred to in item 4.17 shall be applied to the regional agency of the Ministry of Labor and the requirement should contain the following data: *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

- a) the names of the professional members of the Specialized Services in Occupational Safety and Health;
- b) the registration numbers of the professionals in the Secretariat of Occupational Safety and Health of the Ministry of Labor;
- c) the number of the applicant's employees and the risk level of the activities per establishment;
- d) a specification of the work shifts per establishment;
- e) the working hours of the professionals in the Specialized Services in Occupational Safety and Health.

4.18 The Specialized Services in Occupational Safety and Health, which are already constituted, shall be resized in accordance with this NR and the enterprise shall have 90 (ninety) days starting from the publication of this Norm in order to carry out a resizing and registering referred to in item 4.17. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.19 The enterprise is responsible for compliance with the NR, and shall ensure the professional practice of the components of the Specialized Services in Occupational Safety and Health as one of the means to fulfill this responsibility. The impediment of such professional practices, even if partial, and the distortion or deviation of duties, together or separately, constitute violations classified in level I4, if duly substantiated, for purposes of the penalties provided in NR 28. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*

4.20 When dealing with service provider enterprises or contractors, the establishment shall be considered to be the location where their employees are carrying out their activities. *(Amended by SSMT Ordinance no. 33, October 27th, 1983)*
